**NB!** The application is submitted only after the applicant's institution has confirmed it via ETIS. **Please follow the deadlines of your institution (University of Tartu 25 March, TalTech 25 March)!**

# General principles

- The applicant must be the PI of the project.
- One application per applicant.
- Applicant's previous application (PUTJD, PSG, PRG) has not fallen below the **qualification threshold „Good“** in at least 1 criterion in 2 previous calls (2022, 2023) or in at least 2 criteria in the previous call (2023).
- Project start: 1 January 2025.\*
- For the duration of the project, applicant will enter into an **employment contract with an Estonian R&D institution** on a **full-time\*** basis.
- **PI's place of work must be Estonia.**
- Starting and team grant projects have to be implemented in Estonia.

# Additionally,

## PSG applicant...

- ...has received PhD 2-7 years ago:  
between **1 January 2018–1 January 2023\***  
+ period of absence from research
- ...after obtaining the PhD has gained:  
**research experience in a foreign  
country** OR as a researcher at a **research-  
intensive enterprise** in the same country

The Evaluation Committee may deem an applicant to meet the requirements if, stemming from the specifics of the research, it has not been possible to fulfil the aforementioned mobility requirements.

## PRG applicant...

- ...does not participate in an ongoing starting or team project that will continue in 2025.

## ...consist of:

- **direct costs**, incl. staff costs (salaries with taxes, scholarships);
- **research costs**, incl. subcontracting costs, costs related to the (open access) publication and popularisation of the R&D results, costs related to the protection of intellectual property, travel costs, and other costs that stem from the characteristics of the project;
- **overhead.**

**NB!** The Estonian Research Council will continue with **restrictions on Russia and Belarus** in the new research funding period. We do not fund joint research work or mutual visits with these countries.

# Fixed Grant Amounts\*

## STARTING GRANT (PSG)

- **Small** grant amount is **76,000** euros per year.
- **Large\*** grant amount is **117,000** euros per year.

## TEAM GRANT (PRG)

- **Small** grant amount is **192,400** euros per year.
- **Large\*** grant amount is **270,000** euros per year.



# Requirements for the PSG staff

- All staff members must work/study in the same institution.
- **PSG amount *large*** can only be applied for when the research team includes **at least one member of the senior research staff** in addition to the applicant/PI (workload of at least 0.2 during the entire period of the project).
- Doctoral students/Junior research fellows must be included as members of the senior research staff.

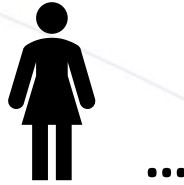


# Requirements for the PRG staff

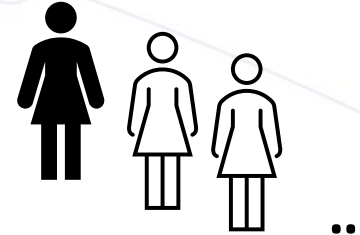
- **PRG project team** must consist of a **minimum of three people** during the entire period of the team project, including the **PI** and **at least one member of the senior research staff**. The third person can be either senior or other research staff member.
- PhD holders must be included as members of the senior research staff.
- **PRG amount *large*** can only be applied for when in addition to the PI, the research team includes **at least three members of the senior research staff** (workload of at least 0.5 during the entire period of the project).
- **PRG amount *large*** can only be applied for when in 2023 and 2024, the PI and the members of the senior research staff have not participated in any starting or team projects that will continue in 2025.

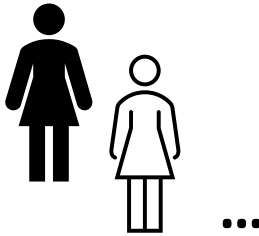

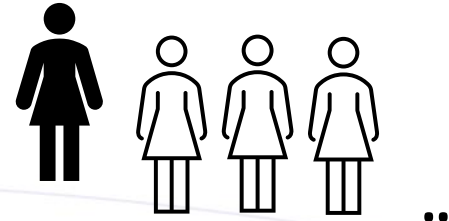

**Names of the people must be shown in the application** and the entire project period has to be covered with the team that meets the requirements.

Senior research staff members cannot participate in several projects/applications during the same period.\*

# The application

- Justification can be up to 24,000 characters (incl. spaces).
- The files that can be attached to the Justification part of the application as **PDFs**:
  - the list of references;
  - timetable (e.g., Gantt chart, incl. deliverables and milestones);
  - risk assessment incl. risk mitigation and back-up plan;
  - figures relevant to the Justification (max 2 files).
- Files **cannot contain long descriptive text** that should be in the Justification.
- **Links cannot be added to the application.**
- The application contains **automatic checks of technical details**. If the application contains an error, the application cannot be confirmed. **Therefore, please give yourself enough time for the confirmation of the application!** List of errors can be found under the "Submit" tab.

Please print out the .pdf file of your application and check if all the relevant information has been provided.

### Submission ?

- Please make following amendments:
  - Tab "Application" > Field "Keywords" is mandatory!
  - Tab "Application" > Field "Summary in Estonian" is mandatory!
  - Tab "Application" > Field "Summary in English" is mandatory!
  - Tab "Application" > Field "Please explain and justify your choice" is mandatory!
  - Tab "Application" > Field "Research type" is mandatory!
  - Tab "Application" > Field "Research experience abroad (e.g., postdoctoral studies, working as a researcher at an R&D institution or at a research-intensive enterprise, etc. in a foreign country) or outside an R&D institution as a researcher at a research-intensive enterprise in the same country" is mandatory!
  - Sum of percentages of fields of research must be 100%!
  - Tab "Application" > Field "Field and speciality" is mandatory!
  - Tab "Application" > Field "Have you used the help of generative artificial intelligence (MS Copilot, ChatGPT, Midjourney, DALL E or similar) for writing or preparing the application or its parts?" is mandatory!
  - Tab "Ethics and data" > Field "Confirmation of adherence to the principles of research integrity and research ethics" is mandatory!
  - Tab "Ethics and data" > Field "Do any of the project's research activities need to be approved by an ethics committee?" is mandatory!
  - Tab "Ethics and data" > Field "Research data management" is mandatory!

# What is new

- **Using generative AI tools for compiling the application is not forbidden**, however, their use must be transparent. For this reason, the first tab of the application form now includes a question concerning the use of AI, where the applicant must clearly indicate, whether and in which capacity AI tools have been used in the application.
- **Changes in the “Ethics” tab of the application:** Changes in the wording of questions and explanations in the “Ethics” tab. The checklist and instructions now include the subject matter of AI.

# Evaluation of PSG and PRG applications

- PSG and PRG applications will be evaluated in **17 Expert Panels** that are based on 7 research fields (see the [list and keywords on the website of the Council](#)).
- The preliminary final evaluation will be sent to the applicants in the beginning of July (at the latest).
- The applicant and the institution are entitled to make objections regarding the preliminary final evaluation (the so-called hearing – deadline **12 August**, objections to be sent to [etag@etag.ee](mailto:etag@etag.ee)).
- The Evaluation Committee will confirm the final ranking lists of each Expert Panel.
- Considering the position in the ranking list and funding amount, the Evaluation Committee will decide which applications will be forwarded to the Panel on Research Ethics and Data Management.
- After the evaluation in the Panel on Research Ethics and Data Management, the Evaluation Committee will make the proposals to approve the applications.



# NB!

- **Read the relevant application guidelines, evaluation guidelines, and budget guidelines that can be found on the website of the Council. NB!** Neither the information on these slides nor in the FAQ section is complete!
- Compile the application in accordance with the guidelines. Add only the files which are allowed. The limitations on the number of characters apply to all applicants.
- All the members of the research staff have to update their ETIS CV.
- PhD information must be added to the CV!
- Members of the senior research staff have to confirm their CV in the application.
- Make sure that the data of your publications is correct (see the bibliometrics guidelines on the website of the Council).

**Please give yourself enough time for the confirmation of the application (consider the auto-check)!**

If something remains unclear, please contact the Research Funding Officer of your field.
